RE: Complaint Against the Park County Republican Central Committee (PCRCC) Chairperson, Deb Elsner, and the PCRCC Executive Committee for Election Interference, Bylaw Violations and Public Campaign efforts for a Democrat Candidate.

Dear Kristi Burton Brown, Republican State Executive Committee, and Republican State Central Committee,

#### The following complaint is against:

- Park County Republican Chairperson, Deb Elsner, in response to State Election Statute violations 1-6-102, 103, 104 and 1-6-119 resulting in Park County Election Interference during the 2022 Primary and General Elections and publicly supporting and campaigning for a Democrat Candidate over a Republican Candidate during the 2022 Primary and General Elections.
- Park County Republican Executive Committee for State and County violations related to, directly or indirectly, supporting and campaigning for a Democrat Candidate over a Republican Candidate during the 2022 Primary and General Elections.

## Summary of Election Interference, Bylaw Violations and Public Campaign Efforts for a Democrat Candidate:

A) Park County Republican Chairperson, Deb Elsner:

- Publicly campaigned and supported the Democrat Candidate over the Republican Candidate for County Commissioner in District 3 for the Primary and General Election of 2022.
- Refused to utilize Republican Election Judges for the General Election if they supported the Republican Candidate for County Commissioner. The only exception to this was the most experienced Republican Election Judge in the County who was severely under-utilized because of her support of the Republican Candidate for County Commissioner.
- Failed to provide a written explanation, as required per Statute, why experienced Republican Election Judges who supported the Republican Candidate for County Commissioner were not utilized in the General Election of 2022.
- Refused to supply Deb Green (County Clerk) with the Election Judge candidate lists for Precincts 2, 3, 7, 11 and 12 following the 2022 Republican Caucus for the Primary Election.
- Refused to certify Election Watchers who supported the Republican County Commissioner Candidate for the Primary and General Election of 2022.

- B) Park County Republican Executive Committee:
- Failed to uphold the State and County Bylaws prohibiting an elected Republican Official from campaigning for a Democrat Candidate while publicly campaigning against a Republican Candidate.
- Failed to oppose or censure the Chairperson's campaign efforts for the Democrat Candidate on social media, local newspapers, at Republican and Democratic events, etc.
- Failed to remove the Republican Chairperson, when presented with verifiable evidence of Bylaw infractions, resulting in damage to the Republican party's reputation and standing in the Park County Community.
- Failed to fulfill their duty to uphold Republican values as Republican Representatives in their respective Districts.

#### We respectfully request:

- 1) Deb Elsner, the PCRCC Chairperson, be immediately and permanently removed from her position and never be allowed to fill a PCRCC elected position again, either on the Executive Committee or as a PCP.
- 2) PCRCC Executive Committee members who failed to oppose or remove Deb Elsner as the PCRCC Chair for her Bylaw violations be removed immediately and never be allowed to fill a PCRCC elected position, either on the Executive Committee or as a PCP. These PCRCC Executive Committee members include Don Comstock (2<sup>nd</sup> Vice-Chair), Timothy Peterson (Secretary), and Monica Douglas (Treasurer). Monica Jones, (who resigned as 1<sup>st</sup> Vice-Chair on 9/15/22 to campaign for the Democrat County Commissioner Candidate), stated in her resignation letter, "I hope to be able to serve the PCRCC in the future." We request she never be allowed to fill a PCRCC elected position, either on the Executive Committee or as a PCP.

We contest those who retained Chairperson Deb Elsner and supported her efforts to elect a Democrat over a Republican for County Commissioner in District 3 have violated RNC rules and are deemed "inoperative and ineffective" per the Bylaw below and should be removed.

To actively support and campaign for a Democrat Candidate over a Republican Candidate, either directly or indirectly through another person, is a violation of National, State and County Republican Statutes and Bylaws.

The following information is based on eyewitness accounts and can be verified by personal affidavits. To protect individuals from retaliation and harassment, names and affidavits have been withheld from this Complaint and will be presented upon request.

We, the Republican Citizens of Park County, feel betrayed by those in the Park County Republican Central Committee (PCRCC) who abandoned their commitment to the Republican Party and values and gave their allegiance to the Democrat Party by supporting, directly or indirectly, the Democrat Candidate for County Commissioner. Republicans who support the Democrat Platform and their candidates, are not Republicans.

It is time to clean up our PCRCC and remove those who supported the Democrat Platform and Candidate while serving as an elected representative of the Republican party. Elected Republican representatives have a duty to support Republican candidates and values. If a person does not feel they are able or willing to uphold that duty, that person should leave their elected Republican position. If they refuse to do so of their own accord, it becomes our duty to see them removed.

#### Park County Republican Chairperson, Deb Elsner's, "Election Judge" Interference:

In mid-October 2022, several Republican Park County citizens and PCP's who had served as Election Judges during the Primary Election of 2022 reached out to the Clerk and Recorders office to gather information on how to schedule as Election Judges for the upcoming General Election. They were informed by Trichon Eisenman, the newly appointed Chief Deputy Clerk who oversaw the Primary and General Elections, that they would not be allowed to judge in the General Election "because Deb Elsner would not approve them". When questioned, Trichon confirmed that the Republican Election Judges who served in the Primary Election were all in good standing with no complaints against them and it was solely a decision made by Deb Elsner, the Republican County Chair. It was subsequently learned that most of the Republican Election. County Chairperson Deb Elsner did not communicate to any Primary Election Judge why they were not selected to serve in the General Election. A written explanation of rejection is required by State Statute 1-6-104 (1, 3).

The Republican County Chair Deb Elsner did not select Election Judges from the available and experienced list of names submitted by Precinct Committee Persons during the 2022 caucus instead she called and recruited most of the Republican Election Judges from the newly formed Park County League of Women Voters, an organization that openly supported Deb Elsner's choice for County Commissioner, Democrat Candidate Ashley Girodo. As a point of reference, on October 24, 2022, Deb Elsner's husband, Dick Elsner, Park County Commissioner and State GOP Treasurer, was asked to resign as the State GOP Treasurer by Kristi Burton Brown due to actively supporting the Democrat Candidate for Park County Commissioner, Ashley Girodo. The attached "supporting document" presents Dick Elsner's "Campaign letter for Democrat Ashley Girodo" and the transcript of his Automated Phone Message for Democrat Ashley Girodo, which were sent to Republicans and Unaffiliates in Park County. Ashley Girodo campaigned as a moderate but was in full support of the policies of President Biden, Governor Polis, and the National Democrat platform. One of the selected "Republican" Election Judges, appointed by Deb Elsner, was a strong supporter of Ashley Girodo. He and his husband, a registered Democrat, were both actively involved with Democrat Ashley Girodo's campaign team. This "Republican" Election Judge was often the only "Republican" Election Judge on-site. For

example, on November 22, 2022, during the Canvassing Count, he was the only Republican Election Judge present. Another, heavily utilized Election Judge was an Unaffiliated voter who served as a Democrat Election Judge during the Primary Election but, during the General Election served as a Republican Election Judge. According to State Statute 1-6-104 (1, 3), (see below), an Unaffiliated voter can only be utilized as a Republican Election Judge if no other Republican Election Judges are available. As stated above, there were 28 Republican voters, from the 2022 Caucus, who requested to be Republican Election Judges. This is a clear violation of State Statute, which resulted in periods of no Republican Election Judge representation during the processing of Ballots.

It became evident that if a Park County Republican was identified as someone who supported the Republican Candidate for Park County Commissioner, Dave Wissel, the Republican County Chair Deb Elsner, prevented them from serving as a Republican Election Judge during the General Election. The only exception to this was Park Counties most experienced and longest standing Republican Election Judge, who had been an Election Judge for 11 years. This Election Judge was heavily utilized by the former County Clerk, Deb Green. However, this Election Judge, who supported the Republican Candidate, was severely under-utilized in her normal lead role as an Election Judge. Her contribution on Election Day was primary limited to checking in voters who wanted to vote in person. Her contribution in the processing room was dramatically reduced and limited. It was a dereliction of duty to limit this Election Judge's contribution in the ballot processing room which was run exclusively by first-time Republican Election Judges.

On September 14, 2022, in response to Deb Elsner's active and public support of the Democrat Candidate and malfeasance toward the Republican Candidate, an attempt was made per Park County Bylaws to remove Deb Elsner as the PCRCC Chairperson. Evidence of her support for the Democrat Candidate can be seen in the attached "supporting document". Unfortunately, the entire PCRCC Executive Committee, and other voting members who followed their lead, failed to support the removal of Deb Elsner, and in doing so, condoned the Chairperson's public support of the Democrat candidate. The attempt to remove Deb Elsner as the Republican Chair exposed those in the PCRCC who were no longer in alignment with the Republican Party Bylaws and values. Republican PCP's, who supported Deb Elsner and the Democrat candidate, were approved by Deb Elsner to serve as Election Judges. Those who opposed Deb Elsner's support of a Democrat Candidate were prevented from serving as Election Judges.

On September 15, 2022, the PCRCC 1<sup>st</sup> Vice-Chair, Monica Jones, resigned her position "temporarily" to campaign for the Democrat County Commissioner Candidate, Ashley Girodo. Monica Jones started the Committee, "Concerned Citizens for Park County", the purpose listed on Tracer is: <u>TO SUPPORT AND CAMPAIGN FOR THE DEMOCRAT CANDIDATE, ASHLEY GIRODO,</u> <u>FOR PARK COUNTY COMMISSIONER DISTRICT 3</u>. The Tracer report for this Committee and their banner "Republicans for Ashley Girodo" is included in the attached "supporting document". This banner was posted at various locations in Park County, including the fence at Deb and Dick Elsner's home, see attached "supporting document". Monica Jones also serves as the County Assessor.

A complaint was sent by Park County Commissioner District 1, Amy Mitchell, to Kristi Burton Brown against County Chairperson Deb Elsner on October 2, 2022, for similar State Statute Election Judge violations, which were not cured. This complaint also highlighted that many of the Republican Election Judges hand-picked by Deb Elsner were selected after the General Election Judge training and were afforded their own training class, which poses additional concerns regarding what they were taught. These actions by Chairperson Elsner have infringed on the State Election Statute for proper protocol Pursuant to section:

#### 1-6-102(1). List furnished by precinct committeepersons.

(1) No later than ten days after the precinct caucus in even-numbered years, the committeepersons of each precinct from each major political party shall submit to the county chairpersons of their respective political parties a list that was initiated at the precinct caucus and that recommends registered electors as election judges. The registered electors recommended as election judges must reside in the precinct and have a current affiliation with the political party that held the precinct caucus.

#### 1-6-103(2, 3) Recommendations by county chairperson

- (2) The county chairperson, or, if there is no county chairperson, the committeepersons who submitted the list of registered electors in accordance with section 1-6-102 (2) shall designate the order of preference of the names of the registered electors recommended to serve as election judges for each precinct. The county clerk and recorder shall select election judges from each precinct list in the county chairperson's, or, if there is no county chairperson, the committeeperson's, order of preference.
- (3) In recommending registered electors as election judges, the county chairperson may select <u>only</u> names from the list submitted by the precinct committeepersons. However, the county chairperson may recommend additional registered electors to the county clerk and recorder <u>if</u> the precinct committeepersons do not provide enough names to the county chairperson.

The precinct committee persons submitted more than 28 names of Republican's requesting to be Election Judges from the 2022 Republican Caucus, which would have been enough to cover the positions for each election location. Many of these Election Judges were used in the Primary Election with excellent results, processing ballots in a timely manner and providing the people of Park County an unofficial completed vote count on election night. Deb Elsner's refusal to utilize Republican Election Judges who openly supported the Republican candidate, Dave Wissel, resulted in an insufficient number of Republican Election Judges. Park County has historically been a red county and according to Deb Green the County Clerk presiding over the Primary Election Judges. During this General Election, there was a serious shortage of Republican Judges because of Deb Elsner's refusal to utilize Republican Election Judges. All, but one, of the Republican Judges handpicked by Deb Elsner were first-time Judges and many did not undergo the regularly scheduled Election Judge

training. This election violation committed by Deb Elsner resulted in a two-day delay in announcing the unofficial total vote count. In total, it took the Election Judges eight (8) days to process 10,167 Ballots before a final unofficial election vote tally was completed.

On most of these ballots processing days, including election day, the ballot processing room had only 5 (five) judges, 2 (two) Republican and three (3) Democrats working. In addition, this delay in processing the Park County votes cost the Park County resident's tax dollars due to additional Election Judge fees. Never in recent history has the Park County unofficial election vote tally been delayed past election day. These actions amount to malfeasance and Election Interference.

Following the Caucus, the Park County Republican Chairperson, Deb Elsner, is required to pass all the Election Judge candidate lists from each PCP to the County Clerk and Recorder. During the Primary Election of 2022, Deb Elsner refused to give the Clerk and Recorder, Deb Green, the PCP's Election Judge candidate lists from Precincts 2, 3, 7, 11 and 12. Deb Green challenged this refusal to provide her with all the precincts lists of Election Judge candidates stating it was "Election Interference" due to not having access to all available resources in conducting the Primary election. Deb Green chose not to run for re-election as the Park County Clerk and Recorder and unexpectantly resigned early from her position on September 15, 2022. County Commissioner, Dick Elsner, supported Melina Kassel as Clerk and Recorder in the Primary Election and swore her in as County Clerk and Recorder on October 4<sup>th</sup>, 2022. During the "recorded" PCRCC meeting on November 9<sup>th</sup>, Melina Kassel was asked why she would not use all available Republican Election Judges to help speed up the processing of ballots. Melina stated, she cannot use an Election Judge unless Deb Elsner, the Republican Chair, approves them. This statement is contrary to the Statute below.

County Chairperson Deb Elsner violated the tenets of Election Integrity as <u>she</u> appointed the Election Judges not the County Clerk and Recorder pursuant to section:

- 1-6-104(1, 3). Appointment of election judges by county clerk and recorder and designated election officials.
  - (1) For each election coordinated by the county clerk and recorder, the county clerk and recorder shall appoint election judges for each location where election activities are occurring.
  - (3) If, at the time the county clerk and recorder appoints election judges, the list of recommended election judges submitted in accordance with section 1-6-102 contains an insufficient number of names for a major political party's share of the total number of election judges as required in section 1-6-109, the designated election official shall appoint any additional election judges necessary from among the persons recommended by minor political parties in accordance with section 1-6-103.5 and the unaffiliated voters who have offered to serve as election judges in accordance with section 1-6-103.7.

## Park County Republican Chairperson, Deb Elsner's, "Election Watcher" Interference:

Prior to the Primary Election of 2022, Park County only had two (2) Election Watchers, serving a total of 30 minutes each in recent election history. Election Watchers have not been encouraged or supported by the PCRCC Executive Committee. A newly elected Republican PCP from the 2022 Caucus, volunteered to recruit, train, and schedule Republican Election Watchers. In hopes of working in conjunction with the PCRCC, the Chairperson Deb Elsner was provided all the required documentation to certify Election Watcher's. During the Republican Candidate Round Table prior to the Primary Election, Deb Elsner was asked why she would only certify two (2) of the Election Watchers sent to her. She replied that she would not certify an Election Watcher who supported the Republican candidate, Dave Wissel, for County Commissioner.

Consequently, Deb Elsner only certified three (3) Election Watcher's for the Primary Election. Deb Elsner was again challenged regarding this decision at a "recorded" PCRCC meeting on August 10<sup>th</sup>, 2022, when she and Dick Elsner both stated she could only certify one (1) Election Watcher per voting station, therefore, she could only certify three (3) Election Watchers. Again, when challenged with this stance, Deb Elsner, as the Chair closed the conversation and would not address questions. During this time, it was unknown to most of the PCRCC that Deb and Dick Elsner were campaigning for the Democrat candidate, Ashley Girodo.

For the <u>Primary Election</u>, most of the Republican Election Watchers who chose to serve were certified by the Republican candidate, Dave Wissel.

For the <u>General Election</u>, Deb Elsner, was again asked via email on October 12, 2022, if she would Certify Election Watchers. Deb Elsner did not respond to this email. On October 31, 2022, Deb Elsner sent an email to the two PCP's she certified for the Primary Election asking if they were available to schedule as Election Watcher's, however, Ballot Processing had begun, and these Election Watchers were already scheduled.

Due to Deb Elsner's refusal to certify additional Election Watcher's, Kristi Burton Brown agreed to certify Park County Election Watcher's as the Republican State Chairperson. This too was blocked when the Secretary of State reversed their guidance and pulled back the ability for State Party Chairs to certify Election Watchers. Republicans in Park County determined to serve as Election Watchers, were able to obtain Election Watcher certification through the other two means available, 1) Write-in Candidate; Stanley Thorne for Attorney General, and 2) Independence Institute Ballot Issue Committee. Therefore, 16 Certified Republican Election Watchers were able to serve the people of Park County during the entire General Election process despite Deb Elsner's interference and unwillingness to certify the Republican Election Watcher's. For those who wanted to serve as Republican Election Watchers in Park County, the Republican Chair Deb Elsner, proved to be their greatest obstacle. Rather than supporting and promoting the Republican Election Watchers, who were certified by the Write-in Candidate and Ballot Issue Committee, she did nothing to ensure Republican Election Watchers were notified when Ballot Processing occurred in the Clerk's office. Unfortunately, 1600 ballots had been processed on October 21, 2022, without Election Watcher's being notified. It was not until the Republican Election Watcher's notified the Colorado GOP Election Security Attorneys that the Clerk's office was forced to provide the dates and times when Ballot Processing would take place.

The Election Watcher's repeatedly documented the processing and counting of Ballots was intentionally delayed, standard procedures were not followed, the Ballot Bag "chain of custody" was not followed, Ballot Bag tags were cut in the Processing Room without allowing the Election Watcher's, who were standing outside the door, to Watch the process. This level of Election Interference by Deb Elsner's hand-selected Republican Election Judges is very egregious and subverts election integrity.

Election Judges appointed by Republican Chair, Deb Elsner, refused to wear required name tags in the Ballot Processing room or wore them in such a way that their names were not visible to the Watcher's. When Watcher's asked for the name of an Election Judge, the Election Judge withheld the information. The Deb Elsner appointed Election Judges were rude and short with the Election Watchers. One Republican Election Judge required the Republican Election Watcher's to stay three (3) feet away from her. The Watchers were only able to comply if it did not interfere with their ability to view the material or screen in use. During the 2022 Primary Election, when Deb Green was the Clerk and Recorder, the Election Watchers were welcomed and treated well by the Election Judges, however, during the 2022 General Election with the Deb Elsner appointed Election Judges the environment was unwelcoming and often hostile to the Election Watchers. Additionally, only 10 total people were allowed to be in the Ballot Processing room at one time. When a county employee or Secretary of State employee chose to be in the Ballot Processing room, an Election Watcher was told to leave the room. The Ballot Processing room was not the same room that was submitted to the SOS for approval. The approved room was much larger than the actual room used. The Ballot Processing room used for the General Election was only about 10' x 12' and every machine and processing station was housed in this room.

The actions listed above outline the Election Interference violations conducted by the Park County Republican Chairperson, Deb Elsner. The Chairperson's Statutory violations against Election Watchers and Election Judges along with her public campaign efforts for the Democrat Candidate have caused the Republicans of Park County to lose all confidence in Deb Elsner as the Park County Republican Chairperson. If the Statute below calls for the removal of an Election Judge, would it not also pertain to the removal of a Republican County Chairperson? The Statute below states, "election judge appointed to represent that party is not faithfully or fairly representing the party...[the] authorized official may exercise a preemptive removal of the Election Judge". Deb Elsner no longer "faithfully or fairly" represents the Republican Party of Park County.

1-6-119 Removal of an election judge by a designated election official.

(1) If a county chairperson of a major political party or the county chairperson or other authorized official of a minor political party believes that an election judge appointed to represent that party is not faithfully or fairly representing the party or that an election judge has moved from the county, the county chairperson or authorized official may exercise a preemptive removal of the election judge. The county chairperson or authorized official shall notify the county clerk and recorder and the election judge of the preemptive removal in writing. The county clerk and recorder shall fill any vacancy created by the preemptive removal as provided in section 1-6-113.

The Park County Republican Chair, Deb Elsner, has violated the trust of Park County Republicans. She has usurped control of the election process in the Clerk and Recorders office, she has violated State Statutes regarding Election Judges and Watchers, she has blocked the privilege of Republicans who signed up at Caucus to serve as Election Judges, she has attempted to block those who desire to serve as Republican Election Watcher's, she has put her personal interest above that of the people of Park County by supporting a Democrat candidate for County Commissioner. Deb Elsner's support of the Democrat Candidate for County Commissioner District 3 can be seen in the attached "supporting document".

Committed Republicans and  $1/3^{rd}$  of the PCRCC members, organized and launched an effective campaign for the Republican candidate for County Commissioner, culminating in Dave Wissel winning the Republican nomination on June 28<sup>th</sup>, 2022. Dave Wissel and his supporters spent countless hours campaigning and fighting against the Democrat machine which aggressively used the support of the PCRCC leadership and  $2/3^{rd}$  of the PCRCC. Dave Wissel was able to prevail and won the Commissioner seat for District 3 against his Democrat opponent, Ashley Girodo. The Republicans of Park County are very upset with the betrayal of the PCRCC. They know their Republican leadership abandoned them and violated many of the National, State and County Republican Bylaws. PCRCC Chairperson, Deb Elsner, cancelled the October and December PCRCC meetings and did not appear at the November meeting, attempting to "cancel" and "silence" those who would address her Bylaw violations and betrayal. This also prevented the Republicans supporting nominee Wissel from filling open PCP positions prior to the Organization meeting on February 8<sup>th</sup>, 2023, when Executive Committee positions will be voted in.

Republicans supporting Commissioner-Elect Wissel continue to work tirelessly against the Democrat Machine which is aggressively seeking to turn Park County Blue. The Democrat party has infiltrated the Park County Republican Central Committee and Executive Committee, through our Chairperson, Deb Elsner, our County Commissioner, Dick Elsner, and our 1<sup>st</sup> Vice-Chair, Monica Jones, who "temporarily" relinquished her seat to campaign for the Democrat Candidate.

As the Republican State Executive Committee, you removed Dick Elsner as the GOP State Treasurer for his Bylaw violation of campaigning for a Democrat Candidate. These are precarious times as evidenced by similar problems in El Paso County, and we need your support to keep Park County Red! We feel that keeping the Republican Party true to its brand, bylaws and conservative position is essential to draw people to our Party and to keep like-minded people from leaving the Party. We should fight to preserve every island of Red in a State that has turned Blue.

Kristi Burton Brown responded to the complaint submitted by Park County Commissioner, Amy Mitchell, saying there was nothing she could do to address these concerns. Dick and Deb Elsner are the source of the Democrat infiltration into the PCRCC. Their open and blatant support of the Democrat Commissioner Candidate and public defamation of the Republican Commissioner Candidate has corrupted the PCRCC Executive Committee and many PCRCC voting members.

# Per the "BYLAWS OF THE COLORADO REPUBLICAN STATE CENTRALCOMMITTEE, ARTICLE XIX: CONFLICT AND SEVERABILITY, INTERPRETATION":

Unless otherwise determined by the Executive Committee or the CRC, should any provision of these bylaws or any rule of the Colorado Republican Party or any rule of any county or district central committee be in conflict with local, state, or federal law, or be in conflict with any rule of the Republican National Committee, then the portion in conflict shall be deemed inoperative and ineffective to the extent of such prohibition without invalidating any of the other provision or portions thereof.
